1. Foreword by the president

Dear friends,

Once again we have the pleasure to submit to you our annual report. The AEPJ has come to a turning point in 2019, growing substantially in the scope of projects funded and executed. Our team around director Victor Sorenssen has managed to push the association towards new heights, at the time when AEPJ celebrates 20 years of activities in Jewish heritage.

In this report you will find a number of issues described, from the statutory issues and internal matters to the association two main projects: the European Days of Jewish Culture and Heritage and the growing European Routes of Jewish Heritage.

The European projects, including the applications for grants are described herein, in order for everybody to understand the wide scope of current activities. Furthermore, this reports contains the institutional agenda of AEPJ, the Director's agenda and its list of tasks and the Communication and Social Media activities.

In addition, important facts of 2019 include the kick-off event in Clermont-Ferrand/France of the European Days of Jewish Culture and Heritage. Many thanks to our board member and president of the French member JECJF, Thierry Koch for his hard work.

Moreover, the renewal of the Council of Europe certification of the European Route of Jewish Heritage has been of tremendous importance. The relaunch of the Route is progressing, we have seventeen Routes that cross sixteen countries. We are proud to work with this European institution and specifically with the European Institute of Cultural Routes and the Director Mr. Stefano Dominioni.

The approval of the – European Commission/EU funded - NOA project together with several other Jewish organizations, namely CEJI, World Jewish Congress, European Union of Jewish Students and EUPJ is another important milestone. In this context, I was privileged to participate and speak on 11 December 2019 in the European Commission's Working Group on Antisemitism at its headquarters in Brussels.

As you see, 2019 was truly an outstanding year for AEPJ. I would like to thank our board for its continuous commitment, notably Assumpcio Hosta, Secretary General and Caroline Lambert, Treasurer for their very precious input. And to all our members and partners for sharing this exciting adventure.

munication and decision making processes to build mutual trust between our institutions. If we are able to generate this type of network, the result will have a much greater impact in the field of European Jewish heritage.

Secondly I would like to comment on our field of work, Jewish heritage. Our approach to the same concept of heritage is evolving. We could say that it is adapting to new trends of heritage management in Europe, while taking a much more ambitious role. Here it is important to note that the nature of the Jewish heritage is complex. Our field of work integrates more than two thousand years of history, a good part of that marked by a legacy that includes very dark pages of European history, such as the Second World War. Here, the challenge is to create positive narratives, without escaping or without hiding parts of a heritage that touches the deepest sensitivities. Because of this fact, it is more important than ever to be able to engage all the necessary and relevant actors in these kind of projects.

Although these facts force us to be very careful, it is also true that it invites us to be in a privileged position. Cultural dialogue and understanding is increasingly important in multicultural Europe. It creates awareness of cultural diversity and strengthens citizens' cultural identity. It shows us what can be achieved when cultures meet and inspire each other. It also promotes fundamental European values of human rights, cultural diversity and intercultural dialogue. The objective, to bring the Jewish heritage closer to all European citizens, involving them in the production, circulation and conservation of Jewish culture and heritage. We believe that such open process of interpretation may stimulate European citizens to co-construct a common democratic perception of their history. And we believe that this is the best antidote to any kind of discrimination, including anti-Semitism, that it is based on ignorance.

I cannot finish without thanking the Board and the representatives of the member Associations of the AEPJ for the confidence they have placed in me. A special thanks to Assumpció Hosta, a real mentor for me, who has helped me grow as a coordinator. It is a privilege to work for the AEPJ. With members of the Board, representatives of the institutions and members of the scientific committee, I not only work, but I live a constant learning experience. With all of them, we have shared ideas, projects, dreams and also, some headaches. It has been a fascinating year and my commitment will be to continue to give the maximum effort in 2020, so that the AEPJ can be much more than a network.

2. AEPJ, Presentation

2.1. AEPJ, much more than a network.

It is a real pleasure to present this annual report of the AEPJ. 2019 has been a vibrant year, as indicated by our president in his foreword, and our Association has taken very important steps in relation to the development of our headline projects. The European Days of Jewish Culture are reaching adulthood with the celebration of their 20th anniversary and the European Routes of Jewish Heritage are starting to take off. In addition, the AEPJ has seen how its participation in European projects has increased and we continue working to add more in the coming years. New collaborations, new partnerships that allow us to continue thinking, and dreaming, big.

I would like to take advantage of this presentation to share two reflections on the work we are doing. Firstly, on the very nature of the AEPJ. Our Association is a European network of institutions working towards the promotion, protection and preservation of the Jewish heritage in Europe. This year we have grown to 23 institutions, representing 16 countries. However, working together in a network is one of the most complex forms of organization. The relevance here is not only the possibility of working together and extending our network throughout Europe, but the shared will to build a community together, a community of ideas. We believe that a network can be much more than a group of institutions working together. Being able, together, to rethink, reflect, reformulate, share and of course, work hand in hand. To this end we try to carry out an effective coordination in terms of time, com-

A non-profit making association is being created, governed by the provisions of the modified Law of 21 April 1928 and by the present articles of association. The association shall be called EUROPEAN ASSOCIATION FOR THE PRESERVATION AND APPRECIATION OF JEWISH CULTURE AND HERITAGE, abbreviated as AEPJ, hereinafter called the Association.

Article 2 – Registered office

The registered office of the Association is in LUXEMBOURG, 1, rue Jean Pierre Brasseur L-1258 Luxembourg. It shall be able to be moved by a two-thirds majority resolution of the Board of Directors.

Article 3 - Duration

The Association is being formed for an indefinite duration.

Article 4 - Object

The Association shall have the objects of working for the preservation, access to all and the appreciation of Jewish culture and Jewish heritage, primarily in Europe.

The Association shall encourage and facilitate the opening up to the general public of Jewish sites, including synagogues, cemeteries, ritual baths, museums, Jewish quarters and Jewish monuments.

The Association shall also have the task of developing and making known the EURO-PEAN ROUTE OF JEWISH HERITAGE.

The Association shall be able to organise any activity directly or indirectly linked to its objectives.

3. By Laws

3.1. European association for the preservation and appreciation of jewish culture and heritage (AEPJ)

A non-profit making association

Article 1 - Name

Of the undersigned:

- Mrs. BLOCH Claude, without trade, living in Strasbourg (France), of French nationality
- Mr. MOYSE François, lawyer, living in LUXEMBURG, of Luxembourgian nationality

Article 5 - Members

The Association shall consist of at least three members. Members may be individual members, associations or other legal groups and legal persons of public law (local, regional or national).

Admission

Joining the Association shall take place by a written application to the Board of Directors, which shall determine the criteria for admission and which shall be communicated to all candidates. The Board shall rule on the said application at a future meeting by a majority vote of its members, the vote being ratified by the next General Meeting.

Resignation

Members shall be able to resign by a written notification to the Board of Directors

Expulsion

A member shall be able to be expelled, if he shall act against the interests of the Association or of its members. An interim decision to expel a member shall be taken by the Board of Directors by a two-thirds majority. The member in question shall be entitled to make oral or written explanations to the Board of Directors. The said explanations shall be considered by the Board of Directors before a final decision is taken. Between the moment of the proposal of expulsion drawn up by the Board of Directors and the final decision by the General Meeting, the member whose expulsion is under consideration, shall be suspended from his functions without further notice.

A member who shall cease to be part of the Association shall have no rights to draw on the social fund.

Honorary members

Honorary members shall be able to be co-opted by the Board of Directors of the Association and shall have a consultative vote at General Meetings.

Contributions

An annual contribution shall become payable by every member. The amount shall be set by the General Meeting on the proposal of the Board of Directors, but shall not exceed 50,000 EURO a year.

Article 6 – General Meeting

The General Meeting is the highest authority of the Association. It shall have the power to take any decisions relating to the Association.

An Ordinary General Meeting shall be held once a year. A written summons shall be sent by the Board of Directors to every member at least fifteen days in advance. The summons shall contain the agenda as well as any draft resolutions to be debated during the Meeting. Any member shall be entitled to submit in writing a resolution to be debated at the Meeting no later than three days before the date of the General Meeting

An Extraordinary General Meeting shall be able to be called by the Board of Directors by a two-thirds majority or if at least one fifth of the Association's members shall so request in writing

Resolutions of the General Meeting shall be adopted by a two-thirds majority of voting members, the adoption being valid only with the votes of the initiators of the association. Every collective member has one vote. Individual members only have a consultative vote. As a general rule, the General Meeting will try and reach decisions by consensus.

The agenda of every General Meeting shall contain at least the following points:

- Submission of the Association's accounts for the past financial year and of the budget for the
- Coming year
- Report of the Association's activities
- Flection of the Board of Directors
- Nomination of an auditor
- Ratification of new members

Resolutions of the General Meeting shall be recorded in a register signed by the chairman and/or the secretary and shall be available to members at the office of the Association. Interested third parties shall be able to obtain extracts from the minutes of the General Meeting on submitting a justified request.

Article 7 - Supervisory Board

A Supervisory Board shall be able to be created, whose task shall be the verification of the good functioning of the Association and of strategic decisions. It shall consist of representatives of the partners involved in the European Route





of the Jewish Heritage and in the European Day of Jewish Culture.

The Supervisory Board shall be available to give guidance to the Board of Directors, which is responsible for the day-to-day management of the Association. For that purpose, the Board of Directors shall be invested with all powers, which are not the sole province of the Supervisory Board.

Article 8 - Board of Directors

The Association shall be managed by a Board of Directors consisting of 3 to 20 members.

The Board of Directors of the Association shall consist of the following officers, namely, a Chairman, one or more Vice-Chairmen, a Secretary-General and a Treasurer.

All members of the Board of Directors shall be elected by the General Meeting for the period of office of one year. Their tasks shall be equitably distributed among all member-organisations, including initiators of the association. The chairmanship and the vice-chairmanship(s) shall rotate and shall be allocated to a different member-organisation every year.

In the event of a vacancy or disability occurring during a period of office, another member shall be able to be co-opted by the Board of Directors, who shall complete the period of office of the member whom he shall have replaced.

Members of the Board of Directors shall be subject to being dismissed by the General Meeting by a resolution taken by a two-thirds majority or members present or represented.

The Board of Directors shall manage the affairs of the Association and shall take all decisions in the interest of the Association. The Board of Directors shall meet at least once a year. However, consultation may also be dealt with by telephone, telefax or by any other means of communication. The Board of Directors shall be free to delegate current business to one or more inside or outside persons.

Resolutions of the Board of Directors shall be adopted by a simple majority of members present or represented. In the case of a tie, the Chairman shall have a casting vote.

Resolutions shall be recorded in a register signed by the Chairman and/or the Secretary and shall be available to members for inspection at the office of the Association.

Article 9 - Finances

The Association shall be financed, in particular by

- Annual contributions
- Voluntary contributions
- Cash gifts
- Subventions and subsidies

The financial year shall begin on 1 January and end on 31 December.

Article 10 - Accounts

Accounts shall comprise a balance sheet and a profit and loss account. The accounts shall be submitted annually to the General Meeting, after verification by the auditor.

Article 11 - Liquidation/Dissolution

The Association shall be able to be dissolved by a resolution of the General Meeting by a three-fourths majority of the votes of members present. In the event of liquidation, a liquidator shall be appointed by the Board of Directors. The corporate entity of the Association shall continue in being pending the completion of the liquidation. In the event of dissolution, the net assets of the Association shall be devoted to a philanthropic object or to an association with similar objectives.

Article 12 – General provisions

In respect of everything not covered by the present article of association, reference is made to the modified Law of 21 April 1928 concerning non-profit making associations and foundations





to strengthen the knowledge about the Jewish presence in Europe through culture and heritage: to encourage and train young Jewish adults for leadership in the Jewish communities.



CoopCulture

CoopCulture is a cooperative operating in the heritage and cultural activities sector in Italy. CoopCulture is a qualified partner positioned to offer answers and solutions to the increasingly complex needs of a continuously evolving sector, from the perspective of integration between cultural heritage and territory and between culture, tourism and local economy.

The Diputació de Lleida is a county council institution that has its reason for being in the town councils of the Region of Lleida, Catalonia. Presided over since 2011 by Joan Reñé, the corporation jointly with the L'Institut d'Estudis llerdencs, and the Tourism Board, create a project under the moto "Perseguits i Salvats". This project recovers and indicates the four itineraries used around 80,000 refugees to escape the Nazis in the World War II, it is estimated that about 20,000 were Jewish. This initiative coincides with the recovery of the Chemin de la Liberté (liberty road), route of evasion that joined the French Department of Ariège with the region of Pallars Sobirà, The routes are about 150 km. distributed around different regions in France and Spain Pyrenees.

4. Governance and Network

41 Members

The AEPJ is formed by Board Members, Members, and Associate Members. The members are normally associations, whereas they can also be individuals.

There are three categories of membership:

- Member (From 1,000 up to 10,000 euros annual fee) shaping AEPJ policies and direction, invited to all events, participation into general meetings, ongoing contact with AEPJ, invited to contribute to AEPJ strategy, formally recognised as a member in AEPJ materials
- Individual Member (25€ annual fee) invited as consultants to contribute to AEPJ strategy.
- Associate Member (no payment) invited to Days/Routes coordinators meetings, ongoing contact with AEPJ

The AEPJ is formed by the following member organizations:



Bnai Brith Europe

B'nai B'rith Europe is a Jewish association that is present in 28 countries. B'nai B'rith means "Son of the Alliance" - the concept of alliance is a key concept in the Bible and in Judaism - and it has non-governmental organisational status. Its role is to fight racism, xenophobia and anti-semitism; to support the State of Israel; to help the needy; to promote Jewish identity;

Israeli House, Georgia

Its goal is to achieve solidarity by public diplomacy (Hasbara) and enhance the cooperation between Israel and friendly states (among them Georgia). At the Israeli House, lectures on topics related to Jewish Culture and Heritage are conducted regularly; meetings, exhibitions, presentations, and seminars in various spheres - cultural, economic, business, medicine, new technologies, political life, and much more are organized







Lithuanian Jewish (Litvak) Community

Is an association of seven regional/local communities and twenty other Lithuanian Jewish active organizations. The aim of LJC are to bring together all the Lithuanian Jews, to defend and look out for their interests in Lithuania and abroad, preserve and celebrate Jewish traditions, cultural and historical heritage, to keep the memory of the Holocaust victims alive, to promote tolerance and fight anti-Semitism and to build and nurture various relations and connections with Jewish and Litvak organizations and individuals all over the world.



Jewish Cultural Heritage Route Association

Jewish cultural heritage route association has been established in December, 2015 by the agreement between Joniškis, Kėdainiai and Ukmergė municipalities, Museums' Association and Centre for Studies of Culture and History of East European Jews. Association seeks to: 1. to preserve and present a numerous heritage of Lithuanian Jewish culture, which is in the territories of different municipalities, while creating Jewish cultural heritage routes both on regional and national levels; 2. to encourage regional interests about Jewish culture, traditions and heritage, to promote visiting and presenting objects related to Jewish history; 3. to contribute to both national and international dissemination of unique historical, cultural and intellectual heritage of Litvaks. At this moment Association has 13 members, 8 of them are municipalities and the rest of them - public institutions and funds, working on the promotion of Jewish heritage.



Ministry of Culture and Tourism Azerbaijan

The Ministry of Culture and Tourism of the Azerbaijan Republic is a governmental agency within the Cabinet of Azerbaijan in charge of regulation of the activities in and development of tourism and promotion of Azerbaijani culture. Since 2016 joined the AEPJ and they work in a specific itinerary through Jewish local sites.



Patronat Call de Girona

The Patronat is responsible for the physical and cultural restoration of the Jewish heritage in Girona, including the renovation, revitalization and promotion of the historic Jewish Quarter, named Call. The Museum of Jewish History and the Nahmanides Institute for Jewish Studies are the two main bodies.



Journées Européennes de la Culture et du Patrimoine Juifs - France

Association dedicated to the promotion and preservation of French Jewish heritage and to the spreading of information about French Jewish culture. For 15 years, from September to December, JECPJ-France has been contributing to the European Day of Jewish Culture by organizing conferences, on-site visits, exhibitions, concerts, etc. in various French Regions.

Red de Juderías de España - Caminos de Sefarad (Network of Spanish Jewish Quarters) is a non-profit public association with the goal of protect urbanistic, architectural, historical, artistic and cultural Sephardic Heritage in Spain. It is a cultural and touristy network that brings together 19 members. The association is a founding member of the AEPJ.


Haggadah Asociation

Izmir Project

Izmir in Turkey is the only city in which an unusual cluster of Synagogues bearing a typical architectural style dating from the 16th century are preserved. These Synagogues built by decedents of Jews who were deported from Spain & Portugal are an historical architectural complex which is unique in the world.

The aim of the Izmir Project is to turn the compound of these ancient Synagogues into a Jewish Heritage Museum, which will tell the story of Sephardic Jews expelled from Spain and arrived in the Ottoman Empire. This future museum will expose the mutual influence of Jewish and Muslim cultures and the inter cultural dialogue between them.

This hopefully restored complex of Synagogues was confirmed in Izmir city-plan, as the future Jewish Museum of Izmir, and we at the Kiriaty foundation are working closely with Izmir Municipality and the local Jewish community to realise, and promote it.



Jewish Community of Zagreb

Today, there are approximately 1 300 members in the Jewish Community of Zagreb, who enjoy their full and equal rights along with support of the government. Although a small community, it remains very active. The Community has many things to offer, amongst which are: The "Mirjam Weiller" kindergarten, The "Lavoslav Schwarz" Foundation Retirement Home, a holiday resort on the Adriatic coast, The "Milan and Ivo Steiner Gallery", a library and archives, a Judaic collection (textile and metals), a Sunday school, a youth club, The "Maccabee" Sports Club, a women's club, a seniors' club, The "Or Hashemesh" Dance Group, Hebrew language courses, "Jewsers" Klezmer Ensemble, The "Miroslav Shalom Freiberger" Cultural Society, a Research and Documentary Centre, and various creative workshops.

The Federation of Jewish Communities in the Czech Republic (FJC)

The Federation of Jewish Communities in the Czech Republic (FJC) is an umbrella organisation representing 10 Czech Jewish Communities and other independent Jewish institutions across the Czech Republic.

FJC coordinates the activities of the Jewish communities' especially in religious, social, educational and cultural aspects. FJC works with Czech government institutions, state administration, local authorities, or other Czech institutions. FJC also functions and cooperates with foreign institutions and organisations.

FJC actively monitors the environment against all manifestations of anti-Semitism, racism, xenophobia, fascism or any other discrimination. Federation protects the memory of Shoah victims. FJC preserves and maintains the Jewish monuments in the Czech Republic, promotes the Jewish culture and heritage, educates the young people and provides care for the elderly, funds Jewish needs and supports Israel.









The Together Plan is a UK charity dedicated to the rehabilitation, repair and revival of Jewish communities coming out of collective trauma in the former Soviet Union and Eastern Europe, enabling, rather than providing, through a self-help approach.

In spite of the traumatic past, there are many who yearn to reconnect with their lost identity. It is the mission of The Together Plan charity, to help those Jews still living in the region learn how to rebuild their communities, and also to reconnect those in the diaspora to their ancestry and the homes they left behind. The Together Plan is playing a vital and much needed role in the repair and renewal process for a better connected and meaningful Jewish future for Jews everywhere.

Tikun is a volunteer, independent, non-governmental, and non-profit association of citizens, established in Novi Sad, Serbia, in 2018.

Members of Tikun share the goal of promoting the multicultural and multi-ethnic heritage of Vojvodina – a province in the northern part of Serbia, with emphasis on the local Jewish material heritage, history, and culture. Some of the association's fields of activity include research and documentation of the Jewish legacy in Vojvodina, protection and preservation of Jewish heritage sites and promotion of the Hebrew language and local Jewish culture and tradition.

Tikun also works on the promotion and nurturing of cultural values and diversity by organising various programmes and events. Its activities rely on donations and contributions from individuals, organisations, and foundations.



Waddesdon Mannor

In 1874 Ferdinand de Rothschild bought the Waddesdon estate and commissioned French architect, Gabriel-Hippolyte Destailleur, to build a country house to entertain friends and family. The project was immense; the hill-top on which the house stands was levelled, drives and terraces were cut and the grounds landscaped and planted with mature trees. Ferdinand, like other members of his family, was an avid collector. Waddesdon is renowned for its superb collections in what became known as 'the Rothschild style' – English 18th-century painting combined with French decorative arts. Today, still managed by the family on behalf of the National Trust, it is a vibrant expression of Rothschild spirit, with thriving programmes of events and activities, changing exhibitions and growing collections of contemporary art and architecture.










6. European Days of Jewish Culture 2019







6.1. European Days of Jewish Culture 2019

The fundamental objective of this European-wide event is to highlight the diversity and richness of Judaism, with the firm intention of promoting dialogue, recognition and exchange through conferences, concerts, performances, guided tours and other activities, which take place simultaneously throughout the continent. For three years this project has been extensively reinforced by the collaboration with the National Library of Israel, who has acted as a means to develop all kinds of exhibition and educational material, which have given an important added value to the Festival, while facilitating its celebration throughout the continent.

Last year, the European Days of Jewish Culture celebrated its 20th anniversary. Therefore, the central theme chosen as the focus of last year was precisely the anniversary of the Festival. Thus, all countries and institutions that participated last year in the European Days of Jewish Culture proposed activities around this anniversary, being able to choose a sub-theme within the 19 previous editions, having the digital material of the National Library of Israel at their disposal.

Members of the AEPJ and the different coordinators then held different work meetings where the development of the European Days of Jewish Culture of previous years was evaluated. The National Library of Israel presented their work in cooperation with the AEPJ in the last three years, through the Gesher L'Europa program.

In the afternoon session, delegates were divided into different committees to work on the following topics: Communication strategies of the network, celebration of the 20 years of the European Days of Jewish Culture and the central theme of the EDJC for the next two years. Likewise, the renewal of the Task Force Group for the European Days of Jewish Culture was approved for the period 2019-2021.

Coordination and development of the EDJC network

The EDJC is a collective project in which institutions of very diverse nature, both public and private, participate: religious communities, town halls, non-profit associations, local governments, volunteers, etc., each of them sharing a common mission, the promotion of Jewish history and culture. Together we form a great network and this is one of the greatest challenges of the EJDC programme: to be able to create a network that is a community of ideas, creating active participation frameworks for local, regional and national coordinators, where we can discuss, evaluate and improve the programme together. To this end, every two years the AEPJ organizes a European meeting of EYDC coordinators, as well as a Task Force, a support committee with representatives from different countries, the NLI team and the AEPJ work together regularly throughout the year.

European EDJC coordinators meeting

On March 28, 2019, the European EDJC coordinators meeting in Tblisi, Georgia, was held with the support of the Israeli House.

The oneday meeting began with the inauguration of the program in the Ministry of Culture of Georgia, with the interventions of: Levan Kharatishvili, Head of the Cabinet of the Minister, Ministry of Culture and Monument Protection; Tamar Chugoshvili, First Deputy Chairperson of the Parlament of Georgia; Hilik Bar, Member of Knesset and Secretary General of the Labour Party; Itsik Moshe, Chairman of Israeli House and François Moyse, AFPJ President.

After the inauguration, Jeremy Leigh, member of the Scientific Committee of the AEPJ, offered a presentation on the role of Jewish culture in Europe today. In the presentation, Leigh discussed the opportunities and different approaches on this axis, in which the work

Task Force Group

This working commission was created in 2017 to help and support the general coordination of the Festival. The duration of each Task Force is two years, so in early 2019 a call was made to the coordinators to present their candidacy to be members of the new Task Force. The list of candidates was ratified at the meeting of European coordinators held on March 28 in Tbilisi.

The challenges set for the new Task Force Group, which will meet once a year in person and every two months by conference call, are the following:

EDJC structure and creation of participatory decision frameworks

Work towards the professionalization of the Festival in two lines. Create a work structure in the form of a network, with a clear set of rules that allows the creation of participatory decision frameworks for all coordinators.

Coordination of a network in constant growth

The EDJC network is impressive and constantly growing. Public, private, Jewish, non-Jewish, national, regional or local institutions join the initiative to work together. Undoubtedly, it is good news that the network grows, but the sustainability of its coordination is increasingly challenging, since there are more needs.

Expansion of NLI materials

The NLI produces very interesting materials, with an excellent, rigorous and dynamic content. In these three years of partnership, the NLI has produced exhibitions, videos, articles, guidelines for activities, etc. A very important number of cities are already using these materials, but there is still a lot of field to work in order to expand the use of the materials. For this reason, in the coming year we will be working on how to maximize the use of materials that have already been produced and those that will be created from scratch.

Difficulty in engaging relevant target groups

Engaging relevant target groups is one of the fundamental objectives of the Project. In addition to local partners' on-site experience, next year we will set up a full communication strategy to diversify and expand audiences in successive waves. Especially relevant will be trying to work with a young audience, to engage them in the project not only as users, but also as producers and programmers of activities.

Once the projects that make up the European Route of Jewish Heritage of the Council of Europe had been defined, a new edition of the AEPJ Incubator Project was planned, in addition to strengthening the AEPJ Heritage Resources on Cultural Routes.

In this context, we would also like to highlight the renewal of the certification of the Council of Europe (see chapter 9), the approval of a new webiste for the project, as well as the agreement with the University of Avignon, through which Federica Pastoret carried out a three-month internship at the AEPJ to support the development of the project. We are pleased to inform that during 2020 Federica Pastoret will join the AEPJ as a full time employee as Project Manager of the Route project.

6.2. AEPJ European Routes of Jewish Heritage Cultural Route certified by the Council of Europe

The year 2019 has been crucial in the relaunch of the European Routes of Jewish Heritage project, which had already begun in 2018. In this sense, during the year different actions were developed with the aim of establishing the framework for the development of the project. At the beginning of the year, following the call for Routes established in December 2018, the work team of the AEPJ together with the Scientific Committee reviewed and evaluated the projects presented. In this way, the following projects were approved and have been officially integrated into the European Route of Jewish Heritage of the Council of Europe:

The Jewish Heritage - Incubator program for EU strategy for the Danube Region (EUSDR)

Held between October 3rd and 4th in Bucharest, Romania, The Jewish Heritage - Incubator program for EU strategy for the Danube Region (EUSDR), within





the framework of the Routes4U initiative, joint program between the Council of Europe (Directorate General of Democracy) and the European Union (European Commission - REGIO DG), through which the AEPJ received a grant to develop the project.

The Incubator was presented, as defined by the AEPJ, as the tool for the development of Jewish Heritage Routes in the macroregion, which includes a twoday program, based on different levels and in a multidisciplinary way.



The aim of the project was to accelerate the process of creating Jewish Heritage Routes in the macroregion and establish the bases for their transnational collaboration through a training program and transnational work sessions among the participants.

For two days, managers of the different Jewish Heritage Routes participated in this pro-


gram, where with the assistance and mentoring of the Scientific Committee they are working on the development of their projects. Likewise, we explored different types of collaborations within the framework of the Danube macro region, presenting future Routes projects and evaluating together the development of the European Route in general. In these two days we were combining key note sessions, workshops in small groups, and sessions focused on the educational field of projects, and on the other hand, the development of networks and the economic sustainability of projects. In these two days we were facing the challenges related to Jewish heritage together, as a community.

For the organization of the Incubator, the AEPJ worked hand by hand with the Tarbut Foundation

New website for the European Routes of Jewish Heritage

This year, as part of the development plan of the European Route of Jewish Heritage project, the Board of the AEPJ approved the creation of a new website for the project. This new website, which will be linked to the general website of the AEPJ, will be adapted to the characteristics and needs of the project. In this way, it will be a key tool to present the different Cultural Routes projects of the AEPJ member institutions. The website will include different functionalities related to the five main priority fields of action of the Cultural Routes of the Council of Europe: cooperation in research and development; enhancement of memory, history and European heritage; cultural and educational exchanges for young Europeans; contemporary cultural and artistic practice; cultural tourism and sustainable cultural development.

Federica Pastoret, who during 2019 carried out an internship with the AEPJ, has been and will be in charge of coordinating the contents of this important project.

I. Research & Development Hub on Jewish Heritage

The AEPJ has its headquarters in Barcelona, in the middle of the old Jewish quarter of the city. The headquarters, called Casa Adret, is a center for research and development of Jewish heritage projects, where in addition to finding offices, thanks to the variety of meeting spaces, seminars, workshops and assemblies are held. HISTORICAL SOCIETY FOR JEWISH HISTORY IN ALSACE AND LORRAINE

Jean Pierre Lambert is chairman of the historical society for Jewish History in Alsace and Lorraine and member of the French team for Jewish archaeology. He was member of the Board of Jewish community Strasbourg from 1995 to 2005, in the heritage department. In addition to various books coordination, papers writing on Jewish history, conferences, exhibitions organisation, he launched the Creation of the "Day of Open Doors of the Alsatian Judaism", first step toward the AEPJ creation, and the JECPJ-France.





III. AEPJ Incubator Project

This AEPJ Incubator Project is an innovative tool created by the AEPJ to accelerate the development of Jewish heritage projects, and specifically, Cultural Routes of Jewish Heritage and its integration into the European Route of Jewish Heritage, through a mentoring process.

The program is defined and implemented by the AEPJ team and its Scientific Committee, tailored made for the participants. The goal is to attract representatives from museums, NGOs, public administration to help them develop their project. Over three days, the AEPJ Incubator Project provides a step-by-step working process - from the idea stage to realization - and includes workshops, seminars, individual tutoring time for each participant, peer-to-peer feedback sessions, and checkins .

The AEPJ has carried out two AEPJ Incubators, one in the headquarters of Barcelona in 2018 and another in Bucharest, within the framework of the Routes4U initiative, joint program between the Council of Europe (Directorate General of Democracy) and the European Union (European Commission - REGIO DG). The results of both programs have been very positive with the participation of more than 60 people, ten experts and the establishment of twelve new routes of Jewish heritage.

The 24 months duration of the DECRA project (2017-2019) will allow to collect data about experiences in the 18 involved networks (through a bottom-up approach), to analyze them and to develop digital tools enabling different target audiences to learn and use these knowledge and skills in order to foster a dissemination and a transfer of these skills and abilities, and thus, to foster educational and cultural cooperation at a European level, i.e. on a non-formal education level and through peer-to-peer learning. In this process, the University of Avignon will also be a strong asset to the project team and to the quality of the reflection and methodology on mediation towards different audiences.

Total amount of the grant to AEPJ: 14.050€

Status of the project: Finished Activities developed during 2019

Six of the eight work meetings proposed in the project were held in 2018, with the participation of the following AEPJ members: UCEI, Coopculture, Patronat Call Girona, Tarbut Foundation and Jewish Heritage Lithuania, jointly with the director, Victor Sorenssen. The last two meetings of the project were held in 2019. The first one in Strasbourg, co-organized by the AEPJ, in collaboration with the JECPJ-France. The second, in Cluny, headquarters of the Cultural Route of Sites Clunisiens.

6.3. AEPJ Projects

The following are the projects with European funding in which the AEPJ has participated in and/or organized during 2019.

ERASMUS+ DECRA: DEVELOPING CULTURAL ROUTES FOR ALL

The ERASMUS+ DECRA project (Developing European Cultural Routes for All) was built on the basis of a common reflection of 18 European Cultural Routes (ECR) - some of these certified as Cultural Routes of the Council of Europe. Recognizing that the transnational networks of the European Cultural Routes gather a whole richness, frequently unknown, of skills, know-how and know-how-to-be necessary to an effective implementation of European cultural cooperation, the different partners (French Federation of European Cultural Routes, Association NETZ - Media and society, Association Transromanica, Association ATRIUM on the architecture of totalitarian regimes in the 20th century, European Association for the Preservation of Jewish Heritage, Danube Competence Center and the University of Avignon) aim at gathering, analyzing, discussing and transmitting, thanks to digital tools adapted and easy to use for a large audience, practices and skills of the members of the European networks of ECRs.

The ERASMUS+ DECRA project has applied this approach to four specific themes, linked to the European Cultural Routes:

- Faro Convention: reappropriation of local heritage and European valorization
- Social inclusion and citizen participation
- Accessibility of monuments and knowledge, including digital accessibility and multilingual
- Longterm development of European networks, including the Social and Solidarity Economy approach.





On January 30, the French delegation of the AEPJ, formed by Thierry Koch and Jean Pierre Lambert (JECPJ-France) offered a guided tour of the Jewish heritage of Strasbourg, including the exhibition of the Alsatian museum.

Final Conference of the DECRA project: Cluny, France 11-13 June, 2019

This meeting, co-organized by the French Federation of European Cultural Routes, Center de Monuments Nationuax, Ville de Cluny and the European Federation of Cluniac Sites, focused on the evaluation of the 22 months of project, as well as the exploration of possibilities for project continuity. CREATIVE EUROPE: PARALLEL TRACES, A NEW LENS ON JEWISH HERITAGE



Parallel Traces, funded by the Creative Europe program, is a cross-cutting, collaborative, cross-European project that offers a renewed look at the significance of Jewish heritage today to create a new window that offers an original and rigorous perspective on the past, present and future of European Jewish history.

The project discovers, rethinks and raises awareness about the European Jewish Heritage as an integral part of European history through different mechanisms: a call for artists, offline and online communication activities, and the development of a new app. A pan-European call, open to creative people throughout Europe, but focused on participating localities represented by local partners of the consortium, will provide an opportunity for the creation of original digital photographic and audiovisual artwork based on clearly

defined criteria ensuring the consistency between the artwork and the project's objectives. This original digital artwork related to Jewish heritage will represent

ROUTES 4U: Jewish Heritage - Incubator program for EU strategy for the Danube Region (EUSDR)



Routes4U is a joint programme between the Council of Europe and the European Union. The 30-month project (2017-20) aims to foster regional development through the Cultural Routes of the Council of Europe programme in the four EU macroregions, according to the Faro Convention.

The 30-Month project (2017-20) enhances regional development through the Cultural Routes of the Council of Europe in the Baltic Sea, the Danube, the Adriatic and Ionian and the Alpine Region. These EU Macro-Regions encompass 27 countries with more than 340 million people.

In this program, the AEPJ participated in the call for grants obtaining a total of 10,000€ to carry out the Jewish Heritage - Incubator program for EU strategy for the Danube Region (EUSDR), described in chapter 6.2.

- The transformation of the EDJC from an open sourced event into a high quality trade mark:
- To create a work calendar that defines relevant actions, in terms of communica-

2. Coordination at European level.

To facilitate the coordination of a network in constant growth is one of the great challenges of the coming years. Likewise, an effective coordination can allow to enhance the impact of the initiative at different levels. In this regard, the following actions are foreseen in two fields:

- A. Task Force Group. This working committee formed by the AEPJ, the National Library of Israel and different coordinators of the EDJC, representative of the different European regions, seeks to be a means of reflection, evaluation, promotion of NLI material, as well as a speaker of the project. The new Task Force Group was created in February 2019 and will be operational for two years. The Task Force Group is the tool to evaluate actions described above through ongoing open participation processes, evaluation and quality control work.
- B. EDJC Information Desk. The objective is to create an information point in the office of the AEPJ where we can carry out work focused on the correct coordination of the initiative. In this respect, looking for new participants through strategic communication processes (communication made to measure for the different institutions); creating regular activities and events throughout the year; management of NLI content and promotion of the EDJC in Europe to increase its impact.





- Sponsor a wide variety of socio-cultural events
- Promote positive Jewish narratives through social media campaigns
- Earn commitments from sporting authorities to combat antisemitism

The AEPJ, in addition to participating in the work packages led by the other members of the consortium, will carry out two actions within the framework of the NOA project, one for the European Days of Jewish Culture and another for the European Route of Jewish Heritage.

Work Package project NOA for the European Route of Jewish Heritage

European Routes of Jewish Heritage of the Council of Europe: "Pluralism seminars"

The European Route of Jewish Heritage, certified by the Council of Europe since 2004, includes 17 countries that develop work in the fields of research, heritage, contemporary culture and art, and cultural tourism and sustainable cultural development. In each of these seventeen countries, an institution leads the Cultural Route project, together with a network of actors in the region. These projects are evaluated by the AEPJ and its scientific committee.

In this framework, and through transnational collaborations among them, grouped into four European macro regions, four seminars/study days, open to all audiences, will be held where the central axis will be "pluralism" as a fundamental aspect of the legacy and heritage of European Jewish communities.

How many participants:

Each seminar will have a participation capacity of about 75 people. The objective of the seminars is to present pluralism as a backbone in European Jewish history, as well as to reflect on and debate the essential role of pluralism in current European societies. The program of Pluralism seminars will have at least 13 active participants, presenting a conference or participating in round tables.

CEJI-A Jewish Contribution to an Inclusive Europe, the European Union of Progressive Judaism, B'nai B'rith Europe, World Jewish Congress, European Union of Jewish Students, and the Association for the Preservation of Jewish Heritage, are teaming up on the two-year project called Networks Overcoming Antisemitism (NOA). In Hebrew, the word 'noa' means 'in motion', referring to the constant movement and evolution of ways to combat antisemitism and also to the progress in highlighting Jewish contributions to Europe. Together, the partners represent 756 national affiliates.

The NOA project aims to:

- Map efforts to combat antisemitism in Europe
- Hold governments accountable through national report cards
- Equip educators with training and teaching tools





European Days of Jewish Culture 2021: "Multicultural Dialogue"

The European Days of the Jewish Culture is an initiative coordinated by the AEPJ that celebrates its 20th edition this year. This Festival, which takes place annually in September, is integrated by a network of 400 cities that include institutions of all kinds: cultural centres, museums, Jewish communities and town halls. Each year, a central theme connects all cultural activities initiatives that propose all kind of activities regarding the central theme: conferences, guided visits, exhibitions, concerts, screenings and lectures. The National Library of Israel has been cooperating for three years as a partner in this project, offering all kinds of materials and contents related to the central theme of the year.

For the year 2021 we propose in the framework of this project, the central theme "Multicultural Dialogue". This perspective invites the different cultural groups to become aware of the enormous richness of existing diversity, represented by their own identities in the different spheres - religious, national and ethnic groups - with the aim of achieving a positive and non-violent coexistence, opening a door to deeply work on antisemitism issues over the diversity of proposals in almost 30 countries at a time.

How many participants:

The minimum forecast for the European Days of Jewish Culture "Multicultural Dialogue" is the involvement of 15 European cities. These cities will be representative of European cultural diversity with a balance of participation of north and south, east and western Europe. The activities developed in this framework will be open to the entire population. The minimum forecast for the European Days of Jewish Culture "x" is 15 European cities. Each of the fifteen activities aims to achieve an audience of 150-200 people, attracting at least 2250 people in total.

9 Cultural Routes

9.1. Renewal of the Council of Europe certification for the European Route of Jewish Heritage

Every three years, certified Cultural Routes are required to submit a report enabling the Governing Board of the EPA to evaluate their activities in order to ascertain whether they continue to satisfy the list of eligibility criteria for themes, list of priority fields of action, list of criteria for networks as well as visibility criteria.

Two main bodies are involved in the regular 3-year evaluation process:

- The Enlarged Partial Agreement on Cultural Routes of the Council of Europe (EPA) is supported by member States, mainly represented by Ministries of Culture, Tourism and Foreign Affairs. The EPA takes the final decision on the renewal of the certification every year during its April's meeting.
- The European Institute of Cultural Routes (EICR), the technical agency set up as part of a political agreement between the Council of Europe and the Grand-Duchy of Luxembourg, supports the EPA's evaluation process. EICR carries out the first assessment of the application and the follow-up of the independent experts' reports.

During 2019, The European Route of Jewish Heritage received the renewal of its certification as a Cultural Route of the Council of Europe for the next 3 years.

On April 10, 2019, the General Secretary of the AEPJ, Assumpció Hosta, and the AEPJ Director, Victor Sorenssen, presented the European Route of Jewish Heritage at the Neumünster Abbey in Luxembourg, within the framework of the process of evaluation of the Cultural Routes of the Council of Europe.

In front of the European Institute of Cultural Routes and the representatives of the 32 States of the Council of Europe signatories of the Enlarged Partial Agreement on these Routes, Assumpció Hosta and Victor Sorenssen presented how the Consortium of the AEPJ supports, in its organization and its actions, the values of the Council of Europe: human rights, democracy, cultural diversity, intercultural dialogue and the promotion of a European cultural identity.

This presentation was the last stage of the renewal process of the certification of our as a Cultural Route of the Council of Europe. In September the AEPJ presented a dossier with







Therefore the certification Cultural Route of The Council of Europe should be renewed.

They have also started a program of development based on raising the quality of projects, to be more effective on the cultural level in the European countries where they work, as well as on the economic and financial plan.

The following recommendations are therefore intended as suggestions to systematize the work they are already carrying out or as new perspectives or methods to work on the topic and the objectives of the Route.

Co-operation in research and development

With regard to this criterion two main recommendations can be made, one on the scientific committee, the other concerning the working methods of national routes.

As for the Scientific Committee, it could be interesting, in the next three years, to insert a figure that deals in particular with the involvement of local communities within cultural projects, in a complementary way to the high level competences already present within the Committee. That would strengthen the interdisciplinary work on both a theoretical and a practical level. The second recommendation concerns the working methods of the members. National routes have different resources and skills, but they have to face the same problems: involvement of local communities, fundraising, work on intangible heritage, An additional work perspective could be to ask each of them to develop a specific competence, to be shared in terms of method, work, actions, with the network, in a process of peer education. That action, thanks to dialogue, exchange of experience, adoption of good practices, could help in facing dispersed knowledge, and to augment the awareness on the European value of the Route, illustrate the variety of form the values of the Route take in Europe, first to the Route members and then to the general public.

Enhancement of memory, history and European heritage

With respect to this criterion, it could be interesting to adhere, at local or national level, to the various manifestations, events or instruments to visit the cultural heritage, so as to propose Jewish heritage integrated with the heritage as a whole. There are a number of initiatives at national level that could be used to give greater visibility to the assets protected and valorized by the Route, in addition to the specific initiatives of the Route itself. Among then one can signal: The European Heritage Days, free Sunday entry into museums that takes pace in some countries, the World Refugee Day with the cultural initiatives for migrants and refugees, ... In addition to these initiatives, there are a number

of instruments to support the demand for the visit to heritage, which the Route institutions could join. As an example one can mention the different museum

all the information on the development process of the European Route of Jewish Heritage. In November 2018, Paola Barrione, of the Fondazione Santagata per l'Economia della Cultura, an independent expert appointed by the European Institute of Cultural Routes, visited the AEPJ office in Barcelona as part of the first training of the AEPJ Incubator Project. In February 2019, Paola Barrione, after analyzing the report and interviewing different members of the AEPJ, made a complete report with assessments and recommendations about our Route for the Enlarged Partial Agreement.

The confirmation, made on April 30 2019 by the Council of Europe's Enlarged Partial Agreement on Cultural Routes, has been based on the report of Paola Barrione and the presentation made in Luxembourg.

Conclusions and Recommendations by Paola Barrione, Independent Expert report:

"EUROPEAN ROUTE OF JEWISH HERITAGE"

On the base of the material analyzed, the filed visits, and the interviews with the Director of the Route and the national routes managers, it can be affirmed that:

- the Route has fully responded to the recommendations expressed during the previous evaluation
- the theme complies with the eligibility criteria for themes, the Route complies with the criteria of priority fields of action and the criteria for networks listed in CM/ Res(2013)67
- the Route implements the communication guidelines





that ideas or new projects may arise from the exchange. In that way the Route could give a positive answer to almost all eligibility criteria for this field of action.

Contemporary cultural and artistic practice

They are working also in this filed, with the Parallel traces project which explores the links between heritage and contemporary culture and tries to break down the barriers between professionals and non-professionals and young and older artists.

Given the great diversity of situations, resources and work capacity of the various national routes, it can be very interesting to collect and share good practices, in order to prepare the ground for new joint projects at European level.

Cultural tourism and sustainable cultural development

They are working in this field as a priority axis, with the idea of starting a path of development and sustainability of the Route on the one hand, of visibility with greater presence in the choice of tourists on the other.

The work I have been able to evaluate is of a high standard, so there are no specific recommendations for the criteria expressed in this specific field of action.

cards active at local or regional level. Becoming part of these circuits should allow Jewish heritage institutions to expand their target audience, raise awareness of the heritage of the Route to people passionate about culture, become more effective on the local cultural scene.

Another recommendation is to ask the member institutions of the Road to adopt the good practice present at the Headquarter of Barcelona in terms of education towards tour operators. The AEPJ organizes training seminars for tourist guides on intangible Jewish Heritage. This type of training is very effective, because it:

- explains the historical significance of physical and intangible heritages and highlight their similarities in the different regions of Europe to practitioners and then to general public;
- takes account of the physical and intangible heritage of ethnic or social minorities in Europe
- helps to raise awareness among, practitioners and then the general public of the complex concept of heritage, the necessity to protect, interpret and communicate it as a means for sustainable development, and the challenges and opportunities it represents for the future of Europe.

The reproduction of this type of education and training seminars for operators at local routes level could be of great help in be effective in enhancing memory, history an heritage at the European level.

Cultural and educational exchanges for young Europeans

In this field, organizations at national level are already conducting many different activities dependent on the local context in which they operate. A recommendation in this case is to collect good practices and share them to all members, so that they can be adopted and

Report 2019





The 2019 Forum was the occasion to discuss challenges and opportunities for the expansion of cultural tourism and the vital role that the Cultural Routes of the Council of Europe can play in its wider development. Representatives of International Organisations (such as EU, UNESCO, UNWTO, ETC, BSEC), EPA member States and Cultural Routes of the Council of Europe focused on how to capitalise the potential for cultural tourism so to foster European heritage and traditions, as well as encourage innovation and creativity in the cultural sector in favour of the tourist experience from different perspectives.

During the Forum, official ceremonies took place to welcome Latvia as a new member State of the EPA and the 5 Cultural Routes of the Council of Europe certified in 2019: European Route of Industrial Heritage, Iron Curtain Trail, Le Corbusier Destinations: Architectural Promenades, Liberation Route Europe and Routes of Reformation.

At the opening dinner, the Minister of Tourism of Romania Bodgan TRIF and the Chair of the EPA Governing Board Birgitta RINGBECK awarded 4 certified Cultural Routes of the Council of Europe for their "Best Practices in Cultural Tourism along the Cultural Routes of the Council of Europe": Iter Vitis Route, Prehistoric Rock Art Trails, ATRIUM and European Route of Historic Thermal Towns.

14 Cultural Routes projects, the 10th Cultural Routes Annual Advisory Forum, which will take place in Chanià (Greece) in 2020, and the 9th Training Academy on Cultural Routes, which will be organised in Fontainebleau in cooperation with the certified Cultural Routes of the Council of Europe "Impressionisms Routes", were also presented at the event.

The Forum was attended by some 200 participants, 20 EPA member States, 25 certified Cultural Routes, 15 new Cultural Routes networks interested in the certification "Cultural Routes of the Council of Europe", representatives from International Organisations (European Union, UNESCO, UNWTO, ICOMOS, ETC, BSEC), NGOs, local and regional

authorities, academics and professionals in the cultural tourism sector.

8th Training Academy on Cultural Routes

Visby, Sweden, 4-7 June 2019

Innovative approaches, challenges and opportunities for sustainable fundraising and youth involvement

The 8th edition of the Training Academy on Cultural Routes, organised by the European Institute of Cultural Routes, the Hansa Cultural Route of the Council of Europe and Region Gotland, took place in Visby, Gotland (Sweden), between the 4 and 7 June 2019.

Expert presentations followed by workshops were held around the themes "Cultural Routes Financing" and "Cultural Routes and Youth". The training seminars explored innovative emerging trends and strategies for funding cultural routes activities and for youth involvement in cultural, educational, tourism and heritage projects, with a special focus on how Cultural Routes of the Council Europe can seize opportunities in these domains.

The 2019 edition of the Training Academy brought together some 60 participants from 15 countries, representatives of 16 certified Cultural Routes of the Council of Europe, 14 networks candidate for certification and involved representatives of other organizations such as the European Commission (Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs) and UNESCO (UNESCO Associated Schools Network)


Facebook, the oldest of our social networks, continues to be our star channel in terms of engagement. Given the profile of our current audience, this is the most common online channel used by them.

Post reach












